### **Collecting and Exhibiting**

- 1990-present – Collects, studies, and writes about fakes, fantasies, and forgeries of Confederate States of America, as well as classic period stamp boxes.
- 1981-1984 – Exhibited “Tokens of Affection” – a postal history collection showing rates from 2¢-80¢ on U.S. Valentine covers of the early classic period. Won Reserve Grand and Favorite Exhibit at HOUPEX 1983, as well as numerous other national shows at the Gold level. Collected Classic Valentine covers from 1976-1984.
- 1970-1973 – Exhibited “Evolution of Confederate Postal History,” co-owned with Brian M. Green. Won Grand Award at FLOREX 1972 and Vermeil in Lima, Peru, 1973.
- 1969 – Became actively involved in organized philately when she joined the American Philatelic Society (APS), Confederate Stamp Alliance (CSA – now Civil War Philatelic Society CWPS), and Society of Philatelic Americans (SPA). Mentored by the top philatelists in those societies and brought aboard in committee and leadership roles from the beginning.
- 1965 – First introduced to Confederate postal history

### **Business Career**

- 2000-present – Full-time retail dealer specializing in American Civil War stamps and postal history
- 2012 – Appraised the Confederate “Lost Plate” by request of Smithsonian National Postal Museum (NPM), which was purchased for display in William H. Gross Stamp Gallery
- 2009 – Appraised major holding for the heirs of August Dietz, Sr. (“Father of Confederate Philately”)
- 1989-1999 – U.S. consultant to British dealer Stephen J. Osborne DBA as Osborne-Kaufmann – dealt in worldwide stamps (few to no Confederates)
- 1988-89 – President and auctioneer, John W. Kaufmann, Inc. – philatelic auction house in Washington, D.C., dealing in worldwide material with emphasis on United States
- 1973-1988 – Vice President and auctioneer, John W. Kaufmann, Inc. – from inception
- 1981 – Kaufmann Auctions sold the first of the 24¢ Jenny Inverts (Scott C3a) recovered from the stolen McCoy block (position 75) on behalf of the American Philatelic Research Library (no commission) at the APS StampShow
- Appraiser of numerous major Civil War philatelic collections
- On-call advisor and expertizer to various major dealers, auction houses and expertizing groups.

### **Publications, Research, Writing, Speaking, Editing**

- 1970-present – researched and wrote about new discoveries in Confederate and U.S. postal history such as hitherto unlisted express mail services which changed (and continue to change) listings in philatelic catalogs, proved new provisionals which were thereby authenticated and listed, identified numerous new stamp varieties, discredited falsely identified varieties in prior catalogs.
- Current – regular columnist in major philatelic publications since 1970: *Civil War Philatelist* (formerly *Confederate Philatelist*), *La Posta* (since 2012), *American Stamp Collector and Dealer* (since 2007), *Kelleher Stamp Collectors Quarterly* (since 2015), and the *American Philatelist*, as well as occasional contributor to other publications, including *Smithsonian Magazine*, *American Philatelic Congress Book*, and more.
- 2023 – Large Gold, “A Cammann Imprint Discovery That Changed a Catalog Listing Plus Insights on Dr. James T. Paterson,” *Civil War Philatelist*, Sarasota National Stamp Exposition.
- 2024, 2022, 2018, 2013, 1971 – August Dietz Award for distinguished original research and writing
- 2024 – Speaker at the British Congress of Philately, Southampton, UK

- 2023, 2017, 2016 – Winner of the *Civil War Philatelist* Writers Award

- 2000 to present – Scott Catalogue Volume 1 and U.S. Specialized Catalogue– annual contributor for content and valuations, as well as a feature writer in select years to explain major changes to the section and content, adding major sections such as the ground-breaking 3¢ 1861 Postmasters' Provisionals, Independent State Mail and Confederate Use of U.S. Postage, completely overhauling how gum is valued in Confederate listings and more.
- 2017 – Large Gold and Reserve Grand at Chicagopex 2017 for *Independent State Mail and Confederate Use of U.S. Postage – How Secession Occurred, Correcting the Record – La Posta* Monograph Series 2, No. 1. Corrected false information that had hitherto been accepted concerning dates when southern states left the Union and created the Confederacy. First published as an article reprint in 2017, which was subsequently expanded as a monograph at publisher request.
- 2017 – Inducted into APS Writers' Unit Hall of Fame
- 2017 – Large Vermeil in literature competition at StampShow as co-author of *Springfield Facsimiles of Confederate Postage Stamps*
- 2016 – Richard W. Helbock Prize for best article in 2016 volume of *La Posta*
- 2012 – Editor-in-Chief *Confederate States of America Catalog and Handbook of Stamps and Postal History*, overseeing and coordinating dozens of section editors over six years. The catalog won the Grand Award for literature at 2013 APS StampShow, as well as top awards in other major competitions. The catalog is the successor to the line of Dietz catalogs, begun in 1932 but completely re-imagined and revised with new research as well as revision of old information, published in full color. “The bible” for Confederate States.
- 2018 – Gold for website trishkaufmann.com at Chicagopex 2018 Literature competition
- 2019 – Reserve Grand, Articles Only competition – Sarasota. “Civil War Prize Court Mail: Profits and Bounty on the High Seas Led to Philatelic Treasures,” *American Philatelist*
- 2000 and 1984 – definitive research on the 3-cent 1861 Postmaster Provisionals, published jointly in both the 1984 and 2000 *American Philatelist* and *Confederate Philatelist*, that resulted in an entirely new section in the 2000 Scott Specialized Catalogue, as well as the CSA Catalog. Her research was a 16-year project, which ultimately disproved the misconceptions of over a century of prior catalog listings, both U.S. and Confederate.
- 1973-1987 – Editor, *Confederate Philatelist* – longest editor in publication history (17½ years)
- 1970-1973 – Co-editor, *Confederate Philatelist*
- 1988-present – Contributing editor, *Civil War Philatelist* (formerly *Confederate Philatelist*.) Also, Associate Editor in various years.
- 1998-99 – Member of CSA Postmaster Provisional Revision Committee working with the publishers of Scott Catalogue to revise this important section. Served in similar capacity for the Minkus Catalog.
